# Introduction to the Youth Trades Program

# **Problem Statement**

Rwanda's youth face a challenging landscape characterized by persistent poverty, limited economic opportunities, and systemic barriers to financial and entrepreneurial empowerment. A significant number of young people are employed in low-productivity sectors, which does not provide a sustainable path out of poverty. This situation is not just an economic issue but also a social one, as it leads to higher instances of juvenile delinquency and reduced civic engagement among the youth.

Moreover, the youth encounter substantial hurdles in accessing finance for entrepreneurship, a critical pathway for economic empowerment and poverty alleviation. The existing financial structures and stringent requirements create formidable obstacles, hindering the youth's potential to initiate and sustain business ventures. This lack of access to financial resources and support systems perpetuates the cycle of poverty and curtails the socio-economic advancement of the youth.

In this context, the YTP is of paramount importance. It stands at the intersection of these multi-dimensional challenges, aiming to provide more than just vocational training. The YTP is positioned to address these broader economic and social barriers, equipping the youth with not only the skills but also the opportunities and resources necessary to navigate and overcome these systemic challenges. The program's role extends beyond education and training; it is about empowering the youth to break free from the cycle of poverty and contribute to a more prosperous and equitable society.

# **Contextual Challenges**

# Socio-Economic Challenges

## Youth Unemployment and Gender Disparities:

As of the third quarter of 2023, Rwanda's youth unemployment rate (for ages 16 to 30) was 21.0%, with the overall unemployment rate at 18.0%. This highlights a significant challenge for young job seekers, who face issues like lack of experience and limited job market access. Additionally, there is a notable gender disparity in unemployment rates, with females experiencing a higher rate of 21.9% compared to 14.8% for males. This underscores the importance of addressing gender-related factors in workforce participation and job opportunities (National Institute of Statistics Rwanda, 2023).

### Skills Gap in the labour Force:

A significant challenge for Rwanda is the skills gap in its labour force. Although sectors like tourism, ICT, and agro-processing are dynamic in job creation, there is a need for skilled labour in these areas. The demand for skilled labour is creating a market bias towards greater income inequality, which necessitates offsetting policies to reduce skill constraints and mitigate wage disparities.

#### **Economic Constraints on Agricultural Development:**

The agricultural sector, while vital for Rwanda's economy, faces economic constraints. These include limited access to financing for farmers, challenges in adopting modern farming techniques, and difficulties in accessing markets, all of which hinder the sector's growth and productivity.

#### Infrastructure and Market Access:

Inadequate infrastructure and limited market access remain significant challenges for farmers in Rwanda. Poor road networks, lack of storage facilities, and limited access to markets often lead to post-harvest losses and reduced profitability for farmers, exacerbating poverty levels.

### **Impact of Climate Shocks and Inflationary Pressures:**

Despite Rwanda's robust economic growth, the country has encountered significant challenges, including the impact of climate-related shocks and inflationary pressures. These challenges have a direct impact on sectors like agriculture and on the overall cost of living, affecting the economic stability of the country and its people. The need to address these issues is critical to sustain and balance economic growth.

## **Challenges in Achieving Inclusive Growth:**

Despite improvements in living standards, Rwanda faces challenges in achieving truly inclusive growth. The reduction in poverty rates has slowed down in recent years, indicating a need for more effective strategies to improve household consumption, especially in rural areas. Addressing this issue requires a focus on infrastructure quality, essential services, and support for entrepreneurship and job creation in the private sector.

# **Educational Challenges**

## **Quality and Relevance of Education:**

Enhancing the quality and relevance of education to meet international standards and local market needs is a critical challenge. This includes improving teacher training, curriculum development, and learning facilities. The focus is also on ensuring that the education provided is aligned with the skills required in the modern job market.

### **Equitable Access to Education:**

Despite efforts to extend basic education, challenges remain in ensuring equitable access across different genders, socio-economic groups, and regions. Rural areas often face greater obstacles in accessing quality education, indicating a need for targeted interventions to bridge these gaps.

#### **Financial Constraints for Quality Education:**

Securing adequate financial resources to provide quality education is a significant challenge. This encompasses not only the funding for infrastructure and resources but also for teacher salaries, training programs, and educational materials. The challenge is further accentuated when trying to ensure equitable distribution of resources across various regions, particularly in rural and underserved areas.

# **Food Security Challenges**

# **Challenges in Agricultural Productivity:**

While initiatives are underway to improve agricultural productivity, Rwandan farmers face several challenges. These include soil erosion, underutilization of terraced land, and the complexities of managing agricultural practices in a changing climate. These issues can adversely impact crop yields and, consequently, food security.

## **High Rates of Food Insecurity:**

A significant portion of the Rwandan population, roughly 20%, experiences food insecurity, with 2% being classified as severely food insecure. This indicates persistent challenges in ensuring adequate food availability and access for all segments of the population (National Institute of Statistics Rwanda, Comprehensive Food Security and Vulnerability Analysis - 2022 Report, January 2023)

# Land and Environmental Challenges

## **Land Disputes and Underutilization:**

Land management in Rwanda faces issues like land disputes and the underutilization of agricultural land. This affects not only food production but also the efficient use of available land resources, crucial for a densely populated country like Rwanda.

## Impact of Climate Change on Agriculture:

Climate change poses a significant challenge to Rwandan agriculture, affecting crop and livestock production. Fluctuations in weather patterns, increased incidences of pests and diseases, and extreme weather events can have detrimental effects on agricultural output and food security.

# Additional Gender-Specific Challenges

## **Economic Participation and Employment:**

While Rwanda has made significant strides in gender equality, economic participation and employment opportunities for women, especially in rural areas, can be limited.

Women often encounter barriers to accessing credit and financial services, which are crucial for starting or expanding businesses.

#### **Gender-Based Violence:**

Gender-based violence remains a significant challenge in Rwanda. Despite legal frameworks and policies aimed at protecting women, the enforcement of these laws and the provision of support services for survivors can be inconsistent. This issue is a critical barrier to achieving true gender equality and empowerment.

### **Health and Reproductive Rights:**

Access to healthcare and reproductive rights are areas where women face challenges. This includes access to family planning services, maternal healthcare, and education on reproductive health. While there have been improvements, more efforts are required to ensure that all women have access to quality healthcare services.

### **Education and Skills Training:**

Educational opportunities for women, particularly in trades, are improving, but disparities still exist. Encouraging girls and young women to pursue education and training in these areas is crucial for their economic empowerment and for addressing the gender gap in high-skilled employment sectors.

#### Socio-Cultural Barriers:

Socio-cultural norms and expectations can limit women's opportunities and choices. This includes expectations related to gender roles, which can restrict women's participation in certain sectors or decision-making processes both within households and in the wider community.

# labour Market Recovery Post-COVID-19:

The Rwandan labour market has shown signs of recovery following the COVID-19 pandemic. The unemployment rate declined from 23.8% in November 2021 to 16.5% in February 2022, indicating a positive performance of the labour market and the resilience of the Rwandan economy despite challenges posed by the pandemic (National Institute of Statistics Rwanda, 2022).



# **Project Capacity**

Within the Youths Trades Program (YTP), the capacity is meticulously defined to accommodate a comprehensive student cohort objectively. The YTP has the ability to enroll 270 students annually, with specific program structures in place to ensure optimal utilization of resources. In the disciplines of Sewing, Culinary Arts, Hairdressing, and Construction, each program operates with two cohorts annually, each spanning 24 weeks and accommodating 30 students. This configuration, when fully enrolled, results in a total program capacity of 240 students for these disciplines. Conversely, the Auto Mechanics program operates once a year over 40 weeks, admitting a maximum of 30 students. At full enrollment, this program contributes an additional 30 students to the overall YTP capacity.

The YTP's commitment to delivering an immersive educational experience is reflected in the allocation of 5 hours of daily education for all students. Moreover, to address basic needs, the program provides a daily meal, totalling 34,800 meals annually when operating at full student capacity.

In summary, the YTP objectively defines its capacity to accommodate students in diverse vocational disciplines, with specific program structures ensuring efficient utilization of resources. The quantitative breakdown illustrates the program's overall capacity of 270 students annually when all programs are fully enrolled.

# Conclusion

The YTP represents a forward-thinking approach to tackling the profound socio-economic challenges facing Rwanda's youth. This program transcends conventional vocational training by fostering a holistic model of development that interweaves economic empowerment, social inclusivity, and environmental awareness. At its core, the YTP is a transformative initiative aimed at equipping Rwandan youth with the skills and knowledge necessary to thrive in an evolving economy while contributing positively to their communities.

The YTP's strategic focus on sustainable livelihoods, innovation, and entrepreneurship reflects a deep understanding of the complex layers of challenges that young Rwandans face, including poverty, unemployment, and the lack of access to economic opportunities. By nurturing a new generation of skilled, adaptable, and environmentally conscious individuals, the program is laying the groundwork for a robust and sustainable economic future.

As this report underscores, the YTP is not merely a response to immediate needs; it is an investment in the long-term resilience and prosperity of Rwanda. The program's comprehensive approach to skill development and youth empowerment is a testament to the transformative potential of targeted educational initiatives. In empowering its youth, Rwanda is not only addressing current challenges but is also paving the way for a more sustainable, equitable, and prosperous future.
