# **Problem Statement**

Children and youth in Tanzania face formidable barriers to accessing and benefiting from quality education, severely impacting their ability to achieve their full potential. Persistent poverty, inadequate educational infrastructure, and systemic challenges create significant obstacles throughout their educational journey, from early childhood to higher education. Many schools lack essential resources, trained teachers, and materials, limiting students' ability to excel academically and acquire critical skills, especially in English, which is vital for higher education and employment opportunities.

Economic hardship compounds these issues, as families often cannot afford the costs associated with schooling, leading to high dropout rates and restricted access to higher education. Additionally, the lack of financial literacy and access to resources prevents young people from achieving financial independence and pursuing entrepreneurial ventures, perpetuating cycles of poverty and economic instability. Social barriers further exacerbate these challenges. Gender discrimination and insufficient community support for education particularly affect girls, who may face additional societal pressures that hinder their educational and personal development. These combined barriers result in reduced participation in education and lower civic engagement, limiting the overall potential of youth to contribute positively to their communities and society.

PSEP is designed to tackle these complex challenges head-on. By providing comprehensive educational support, PSEP addresses many of the educational, economic, and social barriers that prevent Tanzanian children and youth from achieving their full potential. Through a holistic approach that includes academic instruction and support systems that target individual students' unique needs, PSEP empowers students to overcome these obstacles, succeed academically, and build a more prosperous and equitable future for themselves and their communities.

# Relevant Contextual Challenges in Tanzania

PSEP addresses the educational needs of children across Tanzania, encompassing both rural and urban environments. These children face a complex array of challenges that significantly impact their ability to access and benefit from quality education. Understanding these contextual challenges is crucial for effectively supporting their educational journey. Here are the key challenges relevant to the local environment and circumstances of these children:

#### 1. Persistent Poverty

Poverty remains a pervasive issue in Tanzania, affecting families in both rural and urban areas. Many children come from households where financial resources are extremely limited, forcing families to prioritize immediate survival over educational investments. This economic hardship often results in children attending school without the necessary supplies, facing hunger, or being unable to afford uniforms and fees. The financial pressure also forces some children to leave school early to contribute to the family income through work, perpetuating the cycle of poverty and limiting their educational attainment and future opportunities.

#### 2. Health Issues, Including HIV/AIDS

Health challenges, particularly the high prevalence of HIV/AIDS, significantly impact the lives of many children in Tanzania. The epidemic has orphaned many children or left them in the care of extended family members, who may be financially and emotionally strained. Children affected by HIV/AIDS often face stigmatization and discrimination, which can hinder their educational and social development. Additionally, health issues such as malnutrition and other diseases compromise their ability to attend school regularly and perform academically.

#### 3. Gender Inequality and Early Marriage

Cultural norms and gender biases play a significant role in shaping the educational opportunities available to children, particularly girls. In many communities, girls are often expected to assume household responsibilities or are married off at a young age, cutting short their educational journeys. Early marriage not only deprives girls of their right to education but also exposes them

to early pregnancy and associated health risks. These practices perpetuate gender inequality and limit the potential of young girls to contribute to their communities and the economy.

#### 4. Lack of Educational Resources and Infrastructure

Access to quality education is often hampered by inadequate resources and infrastructure. Many schools lack basic facilities such as classrooms, desks, books, and qualified teachers. In urban slums and underdeveloped rural areas, overcrowded classrooms and poor learning environments are common, making it difficult for children to receive a quality education. The scarcity of educational materials and the absence of supportive learning environments further exacerbate educational disparities.

#### 5. Parental Education and Involvement

Low levels of parental education and involvement can significantly affect a child's educational prospects. Parents who themselves have limited education may not fully appreciate the value of schooling or may be unable to support their children's learning at home. Economic and social pressures can also limit the time and resources parents can dedicate to their children's education. This lack of engagement can result in lower educational aspirations and outcomes for children.

#### 6. Social and Cultural Barriers

Social and cultural factors deeply influence children's educational experiences. In many communities, traditional beliefs and practices can conflict with modern educational goals, leading to resistance against schooling, especially for girls. Cultural norms that devalue education or prioritize immediate economic contributions from children over their long-term educational development can limit their opportunities for growth and learning.

#### 7. Security and Safety Concerns

In some areas, particularly in urban settings, safety concerns such as violence, crime, and exploitation pose significant risks to children. These threats can discourage school attendance and participation, especially for vulnerable children who may be more exposed to such dangers. Ensuring a safe and secure environment is essential for fostering consistent school attendance and a conducive learning atmosphere.

#### 8. Food Insecurity and Nutritional Deficits

Many children in Tanzania face food insecurity and poor nutrition, which can severely impact their cognitive development and ability to concentrate in school. Hunger and malnutrition not only affect physical health but also limit a child's capacity to engage in learning activities. Schools often struggle to provide adequate nutrition programs, further exacerbating the impact of food insecurity on education

#### 9. Child Abuse and Exploitation

Child abuse and exploitation are serious issues in Tanzania, with many children experiencing physical, emotional, and sexual abuse. This abuse can occur within the home, in the community, or even within educational settings. The trauma associated with such experiences can severely

impact a child's mental health, self-esteem, and ability to concentrate and perform in school. Children who have been abused often suffer in silence due to fear of stigma, retribution, or lack of trust in adults who could help them.

#### 10. Gender-Based Violence

Gender-based violence (GBV) is a pervasive problem, disproportionately affecting girls. This includes domestic violence, sexual harassment, and assault, often occurring in environments where children should feel safe, such as schools or homes. The threat or experience of GBV can lead to anxiety, depression, and withdrawal from educational opportunities, thereby hindering the academic and personal development of affected children.

#### 11. Unsafe School Environments

Schools should be sanctuaries of learning, yet many lack adequate measures to protect children from violence and abuse. In some cases, teachers or school staff may perpetrate abuse, or fail to intervene in cases of peer violence and bullying. The absence of robust child protection policies and training for school staff on recognizing and addressing abuse contributes to unsafe learning environments.

#### 12. Limited Access to Support Services

Access to psychological and social support services is often limited, particularly in rural areas. Children who have experienced abuse or violence require counseling and support to heal and regain their sense of security. However, the scarcity of such services means many children do not receive the help they need, exacerbating the negative impacts on their education and overall well-being.

- **GPS Coordinates**: Recording the precise GPS coordinates of each school's location assists in logistical planning and provides a clear understanding of the initiative's reach.

#### **Enrollment Data**

• **Student Enrollment:** The number of students enrolled in each school is meticulously tracked. This data is essential for measuring the initiative's reach and the scale of support provided to the community.

# **PSEP Breakdown**

The PSEP for the year 2024/2025 serves a total of 45 students, split into primary (19 students) and secondary (26 students) education levels. These students are categorized into two main groups: TCF students and Outreach students.

### Student Breakdown and Individual Impact

**TCF Students:** TCF students include 19 children, with 12 in primary education and 7 in secondary education. These students live at the foundation because they lack viable living options due to adverse family circumstances such as abandonment, abuse, or the death of guardians, and more. Each TCF student receives 7 hours of education daily, five days a week, which totals 1,358 hours of education annually. They also receive one meal per day as part of this program, five days a week, amounting to 194 meals per year. However, it's worth noting that TCF children receive additional support beyond this program, including three meals a day, although only lunch on school days is covered by this program's expenses.

**Outreach Students:** The Outreach group includes 26 students, with 7 in primary and 19 in secondary education. Outreach students primarily live at school boarding facilities, although some live with their families while receiving financial support from TCF. This support covers essential needs such as food, medical care, and clothing, though these are funded by other programs, not the PSEP. Each Outreach student also receives 7 hours of education daily, five days a week, totaling 1,358 hours annually. Non-boarding Outreach students receive one meal per day, resulting in 194 meals annually per student. Boarding Outreach students receive two meals per day, amounting to 546 meals annually. Additionally, boarding students receive accommodation and shelter for 273 days each year, alongside essential items such as bed and cleaning supplies.

- Combined Meals Provided: 17,882 meals

#### **Boarding Support**

- Total Collective Days of Accommodation/Shelter Provided: 7,098 days
- Additional Support: Includes extra meals and provision of bed and cleaning items.

### Financial and Logistical Considerations

The cost of this initiative covers the essential components detailed above. TCF students receive additional support beyond what is included in this program, ensuring their overall well-being and academic success. It is important to note that TCF does not directly manage the education or boarding facilities but places students into high-quality schools to ensure they receive the best possible education.

# **Program Capacity**

The need for support towards vulnerable children is immense and ongoing. The PSEP is positioned to make a substantial difference in the lives of many children during the 2024/2025 year, but its ability to expand relies on the level of support from partners and donors.

While the program currently serves 45 students, the potential for outreach is vast. The Outreach component has significant capacity for growth. The limitation is not in the ability to provide support but in the resources available to sustain and expand the program. The impact of the program can be greatly amplified through increased partnerships and financial contributions.

# Dollar-to-Impact Ratio

The Dollar-to-Impact Ratio (DIR) serves as a metric to evaluate the cost-effectiveness of an initiative by analyzing the financial inputs required to achieve specific outcomes. For the PSEP, the DIR precisely quantifies the cost concerning:

• Student Enrollment by Term Costs

In comparison to:

- Hours of Education Provided
- Meals Provided
- Days of Shelter Provided
- English Proficiency
- Academic Performance

By examining these factors in the DIR, the program can accurately assess the efficiency of its expenditures. It can then optimize how resources are allocated to ensure every dollar invested yields the most significant possible impact. This diligence in resource allocation aims to bring forth transformative change in the lives of the PSEP participants and the community at large. This holistic approach aims to empower participants, enhancing their educational experience and overall well-being, making tangible changes within the local community.


